TERMS AND CONDITIONS

This agreement contains the terms and conditions by which Holidayze (a division of Five Star, Inc.) 810 Belmar Plaza, Belmar, NJ, 07719 ("Operator") in considerations for a Participant's payment, agrees to provide these travel tours. **READ AGREEMENT CAREFULLY BEFORE SENDING ANY MONEY.**

TOUR PRICES: All rates are based on tariffs in effect as of the date of printing. The airfares, if included, used for the tour prices indicated herein are capacity controlled and will be applicable on a "first come, first served" basis and are subject to change without notice.

DEPOSITS: A deposit of \$250. per person is required to your group leader by September 01, 2005.

PAYMENT: If payment is made by credit card: (1) a signed, fully completed credit card voucher for such payment, with proper authorization, must be received to secure reservations. (2) Participant(s) waive any charge back rights for services provided but not utilized. (3) Participant(s) must agree to the 3% surcharge as indicated on the charge form. In the event of a dispute, requests for refunds must be made under the procedure described below.

Cancellations and Refund Policy: Any other person or entity who receives moneys from the Participant(s) does so strictly as an agent for the Participant(s). The Operator disclaims liability for such moneys until received by the Operator's office and confirmation is issued by the Operator. Tender of a deposit constitutes acceptance of these terms and conditions. Complete payment must be received no later than 60 days prior to departure. After deposit, all revisions with the exception of adding insurance will be subject to \$25. charge. No changes will be accepted within 6 weeks of departure. Changes that affect inventory utilization (e.g. date change, hotel change, etc.) will be considered a cancellation.

CHANGES: A \$25. fee will be charged for any changes in the reservation that is requested after the original booking has been processed.

CANCELLATION CONDITIONS: Certain commitments for these arrangements have been, or are being made on your behalf in connection with the tour described on the reverse. Naturally, along with these commitments comes a certain responsibility on your part that will necessitate certain cancellation penalties in the event you cancel your tour arrangements prior to the departure date. All notices of cancellation must be received in writing at our office in order to be considered valid. The amount of refund, if any, will be determined by the following schedule in accordance with the date such notice is received: Prior to 90 days before departure: \$25.00. Between 89 & 60 days: \$275.* Between 59 & 45 days: \$600.*; Between 44 & 30 days: \$925.*; After 30 days: \$1525.*. (*Plus any further charges assessed by hotels, suppliers and airlines. No shows are non-refundable. Charges indicated are **per person**. In the event that a canceling passenger is able to provide a substitute for that canceled space there will be an administrative charge of \$50. to effect that substitution. All substitutions must follow the same itinerary as the passenger being replaced with the exception that there may be occasions where the substitute may wish to purchase additional options. In this event we will make every effort to satisfy that request.

LAND TRANSPORTATION: Ground transportation, as indicated, will be provided by deluxe motor coaches. In the event of insufficient participation, alternate means of transportation may be provided or offered.

HOTELS/MOTELS: Accommodations will be as indicated except in the case of overbooking. However, the tour operator reserves the right to substitute hotels of a similar category

LIFT TICKETS: Lift tickets are optional and available at the resort. Or as described on the reverse.

MEALS: Snacks and meals are served during some flights. Other meals will be as indicated on the reverse.

TIPPING: Tipping is at your discretion.

PASSPORTS AND VISAS: A valid passport is required for all U.S. citizens and is the passenger's responsibility. In addition all US Citizens are required to have a visa in order to enter Australia. For those who are not U.S. citizens, please contact the Australian Consulate for entry requirements. If you would like Holidayze to process the Australian visas, please submit the following: 1. Copy of the photo/detail page from valid passport. 2. \$10.00 check (per visa) made payable to Holidayze. 3. Mail BOTH to: Holidayze, 810 Belmar Plaza; Belmar, NJ 07719 Attn: Visa Processing. Be sure to include the name of your ski club.

BAGGAGE: You are normally allowed 2 pieces of checked baggage plus one carry-on piece that must fit under your seat. Porterage of the carry-on piece is your responsibility. Skis, boots & poles will count as one of your pieces of checked baggage. Baggage is at "owner's risk unless insured. Insurance is recommended and offered below.

NOT INCLUDED: Tour prices do not include items not specified. Also not included, mineral water, coffee where meals are included, excess baggage, passport fees and items of a purely personal nature.

REFUNDS: Since all tours are on the basis of inclusive arrangements, no refunds can be made, considered, or given for any absence from the tour or for any unused services or meals once the tour has commenced and is en route unless arrangements have been made at the time of booking. Any and all claims for refunds are to be made at the booking office, as no agents, representatives, guides or any other persons, are authorized to make or to promise refunds, or to make or promise to make any changes or alterations of the official conditions and regulations. No claims can be considered if not made within 60 days from the completion of the tour. No claim can be considered if it is not accompanied by a completed service adjustment coupon or written authorization from our representatives and/or hotel. Telephone requests for refunds will not be accepted and are not valid. All information and details on resorts, hotels, ski areas, etc. were supplied by the various entities involved. Prices are subject to change, and not all facilities may be in operation at the time of your vacation. If you are in doubt, please ask.
